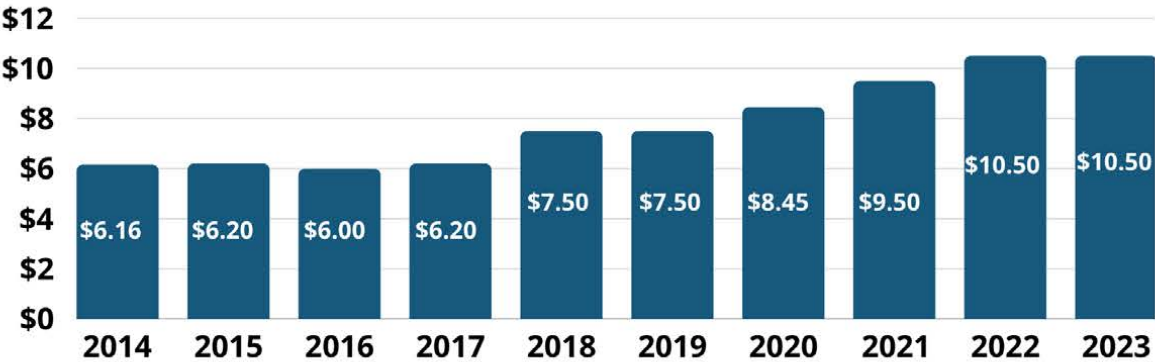

# HERITAGE AND ELDER DISTRIBUTIONS

The Sitnasuak Native Corporation (SNC) Board of Trustees is pleased to declare a Heritage Trust Distribution of \$10.50 per Trust Unit (or \$1,050 for those with 100 Trust Units) to all beneficiaries of record as of November 2, 2023. An Elders Benefit Distribution of \$1,000 per Elder has also been declared for those eligible SNC Trust beneficiaries 65 years of age or older.

The SNC Trust distributions are tax-free to each recipient and will be mailed or directly deposited no later than November 30, 2023.

"The SNC Trust Distributions are more than just a financial distribution - they are a testament to the financial prosperity and stability of the Corporation," said CEO, Charles E. Fagerstrom. "This distribution signifies not only our financial stability but also our unwavering commitment to our Shareholders."



## Heritage and Elder Distributions (continued)

Many benefits are available to SNC Trust beneficiaries and lineal Descendants through the SNC Settlement Trust. SNC provides both direct and indirect economic benefits including distributions, charitable contributions, scholarships, bereavement benefits, discounts with our family of businesses, camp/home sites on our ANCSA lands, and hire preference for qualified Shareholders, descendants, and Shareholder spouses.

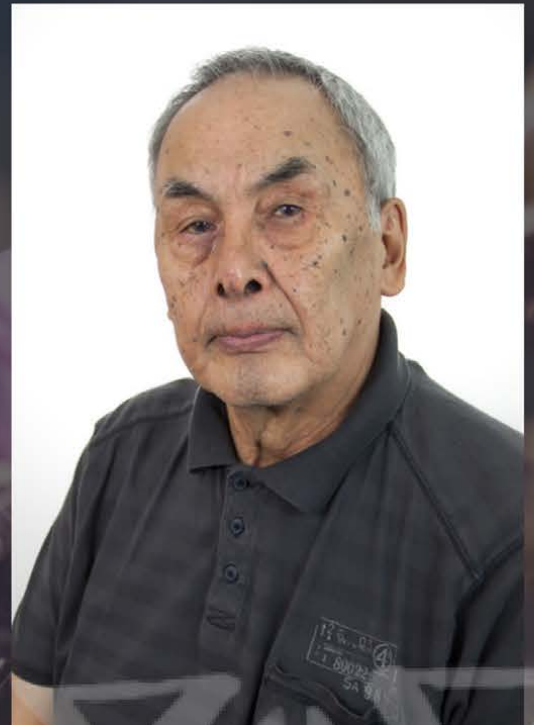
### About the SNC Settlement Trust

The SNC Trust was approved by Sitnasuak Native Corporation (SNC) Shareholders on September 22, 2018, at the 44th Annual Meeting. SNC's shareholders are the Trust's Beneficiaries, and SNC Board of Directors are the Trustees of the SNC Trust. The SNC Trust ownership of trust units is equal to the number of shares of SNC Settlement Common Stock owned by SNC Shareholders. The SNC Trust is an Alaska Native Claims Settlement Act (ANCSA) Settlement Trust with the purpose of promoting the health, education, and welfare of the Trust's Beneficiaries, preserving the heritage and culture of Alaskan Natives, and promoting the long-term economic stability of the Trust's Beneficiaries through distributions and benefits and through the minimization of taxes.

## snc recognizes the passing of **LINCOLN TRIGG, SR.**

Sitnasuak Native Corporation recognizes the passing of former board member, Mr. Lincoln T. Trigg, Sr. who served on the SNC board of directors for over 15 years. First elected in 1983, Lincoln also served on the Sitnasuak Land Committee and the Elders Committee. Lincoln spent many years in the service of our people.

Sitnasuak Chair, Gloria Ann Karmun shared "Lincoln's love of our people and our region were evident. I, along with our board of directors are grateful for his dedication and service to our corporation and community over the years. His impact on the lives of many will not be forgotten."







## sitnasuak ranks #29 in **TOP 49ERS**

Once again Sitnasuak Native Corporation has made its way onto the Alaska Business Monthly Top 49ers list for 2023, ranking no. 29 on the list. This recognition underscores the corporation's commitment to its mission and its significant contribution to the Alaska business economy.

The Top 49ers list is comprised of Alaska businesses founded within the state, and the rankings are determined by gross revenue figures. In 2023, Sitnasuak Native Corporation achieved gross revenue of over \$144 million, positioning itself among the top 30 businesses in Alaska.

This year there was a notable presence of Village Corporations on the list, with three of the top 10 businesses on the 2023 Top 49ers list falling into this category. Additionally, nine out of the top 10 are Alaska Native Corporations, highlighting the strength and importance of these entities in Alaska's economy.

As an Alaska Native Village Corporation, Sitnasuak Native Corporation is deeply rooted in its cultural heritage, committed to serving its Shareholders and communities and fostering economic growth within the Bering Strait Region.

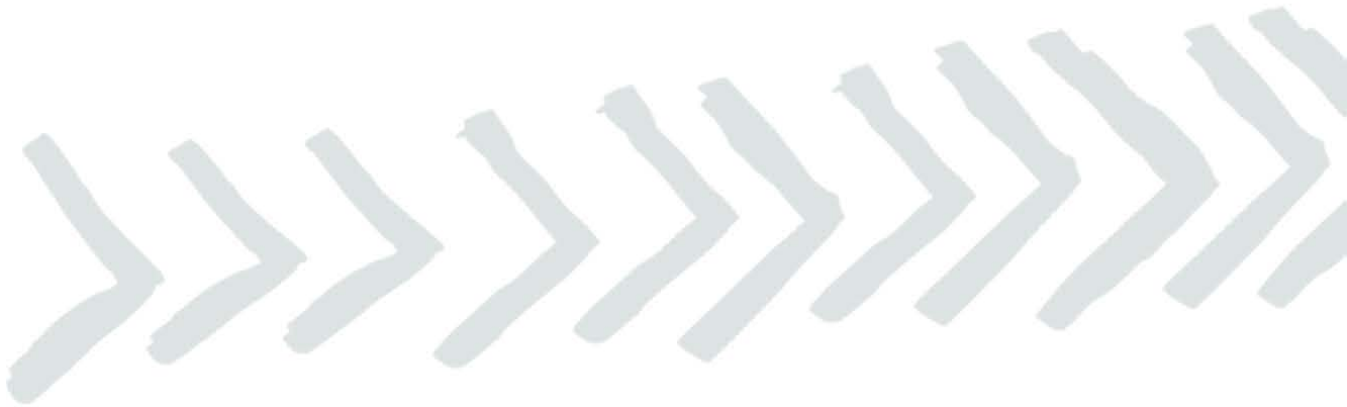

### **ANCSA's 12 REGIONS, A FEDERAL INDIAN RESERVATION & THE 13TH REGIONAL CORPORATION**

The Alaska Native Claims Settlement Act (ANCSA) divided Alaska into twelve regions based on the common heritage and shared interests of indigenous peoples in each area, determining the service areas for Alaska Native regional corporations. These boundaries didn't signify land ownership but guided land selections. Each region now has a complex system of governance, land ownership, roles, and relationships.

At the time Congress passed ANCSA, the Metlakatla Indian Community opted out of the settlement agreement. The community instead chose to be designated as a federal Indian reservation. The Annette Island reserve is the only federal Indian reservation in the state of Alaska.

In 1975, ANCSA was amended to create the 13th Regional Corporation, ensuring that Alaska Native individuals not residing permanently in Alaska but eligible to join a regional corporation could be part of the land claims settlement. Unlike the original regional corporations, the 13th Regional Corporation didn't receive land conveyances under ANCSA, but it can receive 7(i) funds from other Alaska Native regional corporations. In 2013, the 13th Regional Corporation was dissolved involuntarily by the State of Alaska following the resignation of its registered agent.
